1. Grain group (complete list on request) up to 100,000 tons per month.
  2. Compound feeds to order, for cattle and poultry.
  3. Flour of the 1st and 2nd grade (quantity on request) up to 50,000 tons per month.
  4. Pasta (quantity and shape of products on request) up to 50,000 tons per month.
  5. Confectionery, ice cream (quantity and shape of products on request).
  6. Beet sugar (quantity on request) up to 20,000 tons per month.
  7. Dairy products (butter, margarine, milk powder 1.5% and 24%, kefir, yogurt) (quantity and shape of products on request).
